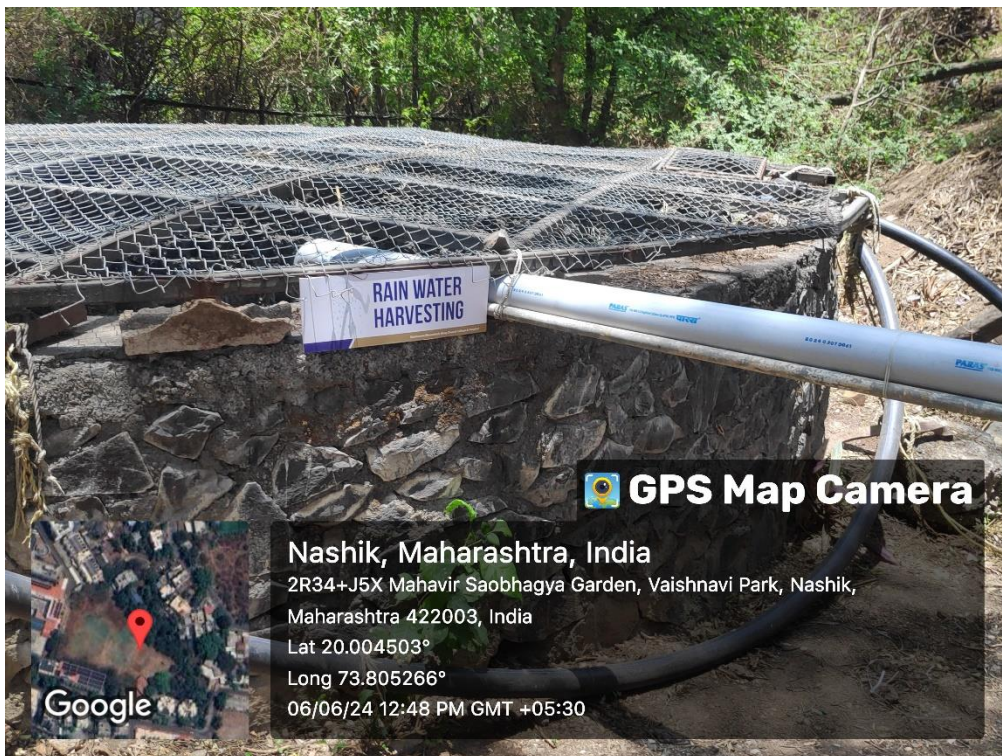

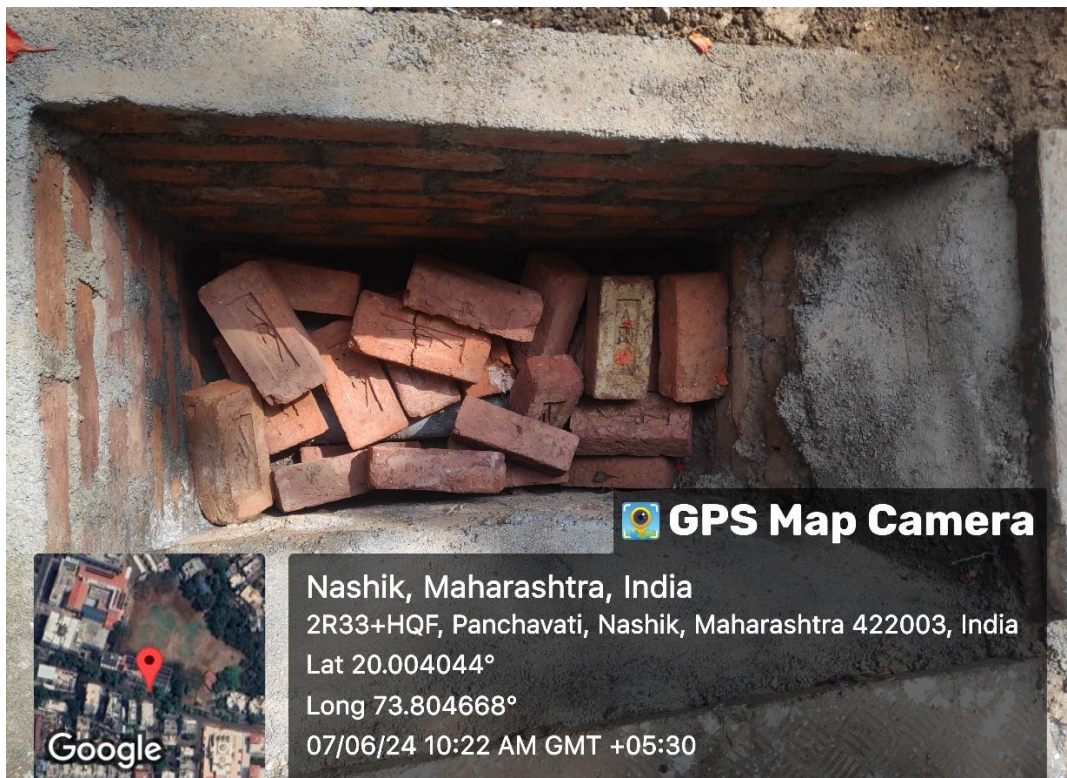

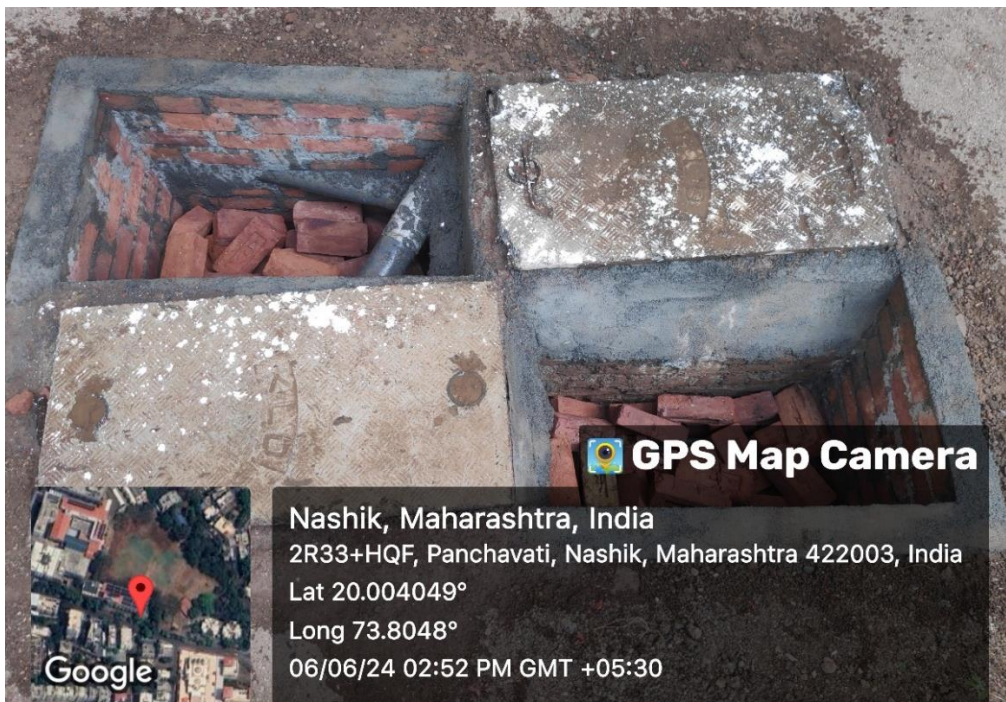

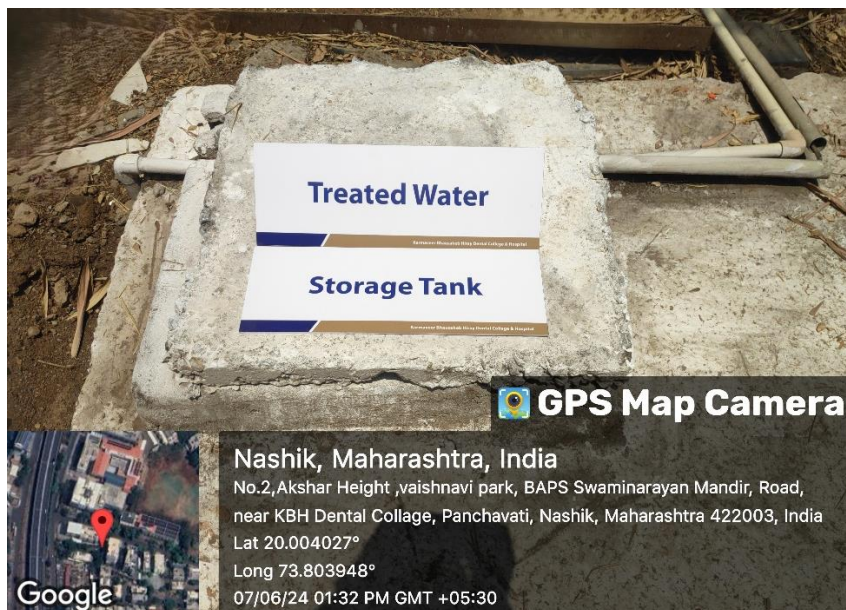

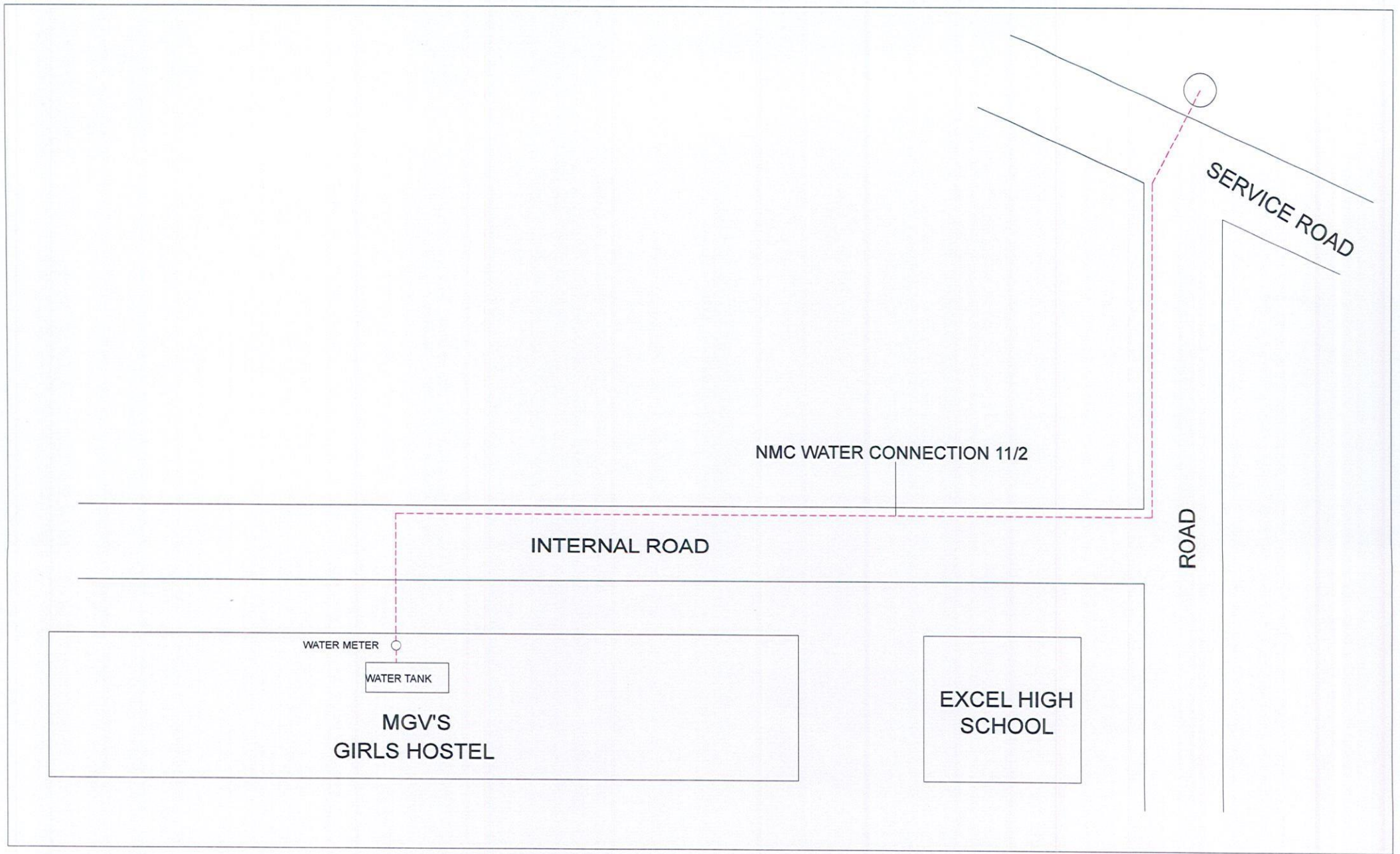

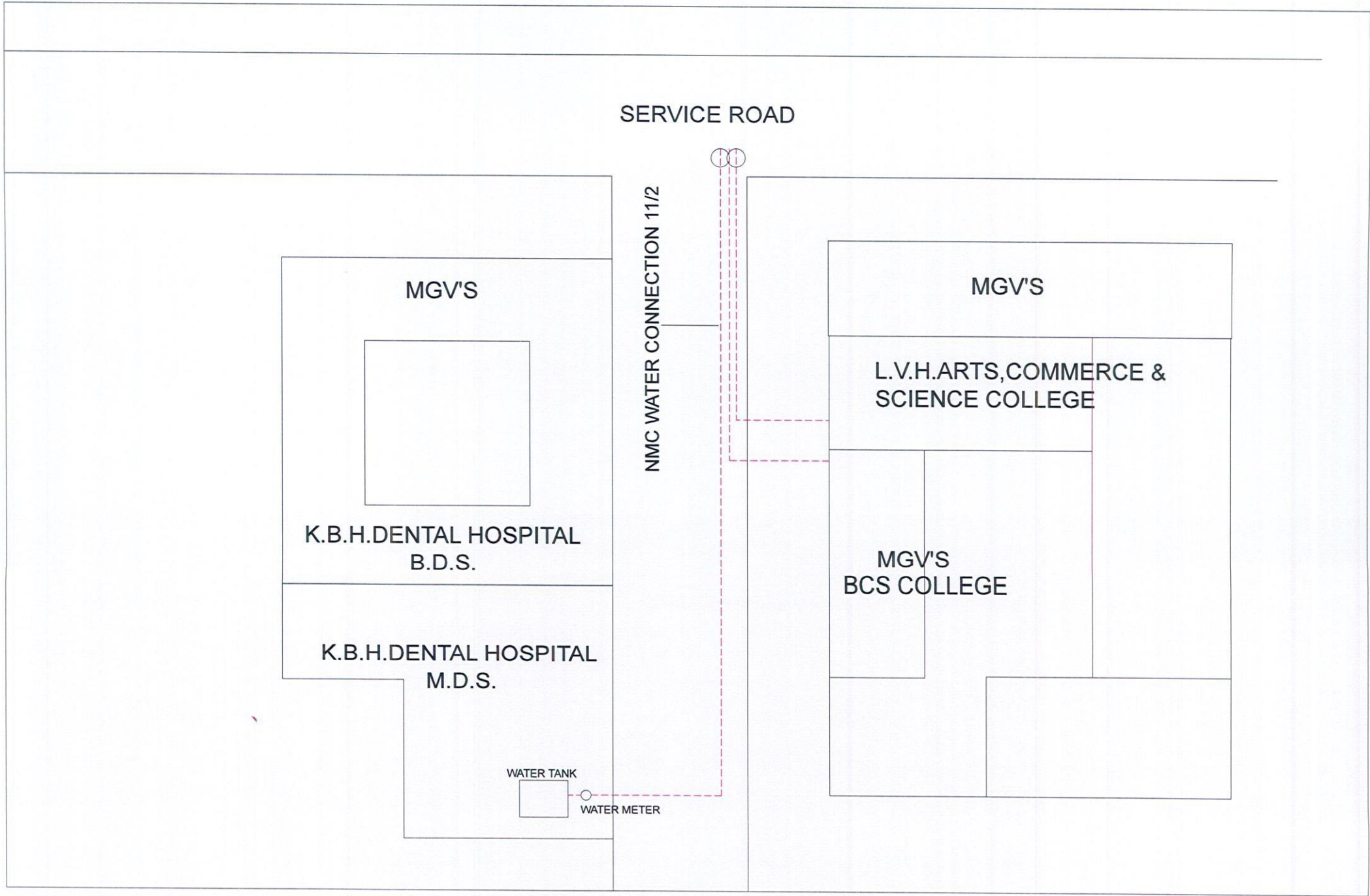

Introduction

The policy outlines the measures for rainwater harvesting, borewell, open well recharge, construction of tanks and bunds, waste water recycling and maintenance of water bodies and distribution system in the campus.

This policy aims to establish guidelines and practices to minimize water consumption and water wastage within the college premises.

- 2) Reduce dependency on external water sources.
- 3) Ensure efficient water distribution and maintenance of water infrastructure.
- 4) Enhance ground water recharge and storage capacity.

Responsibilities:

Faculty and Staff: All faculty and staff members are responsible for adhering to water-saving practices and promoting awareness among students.

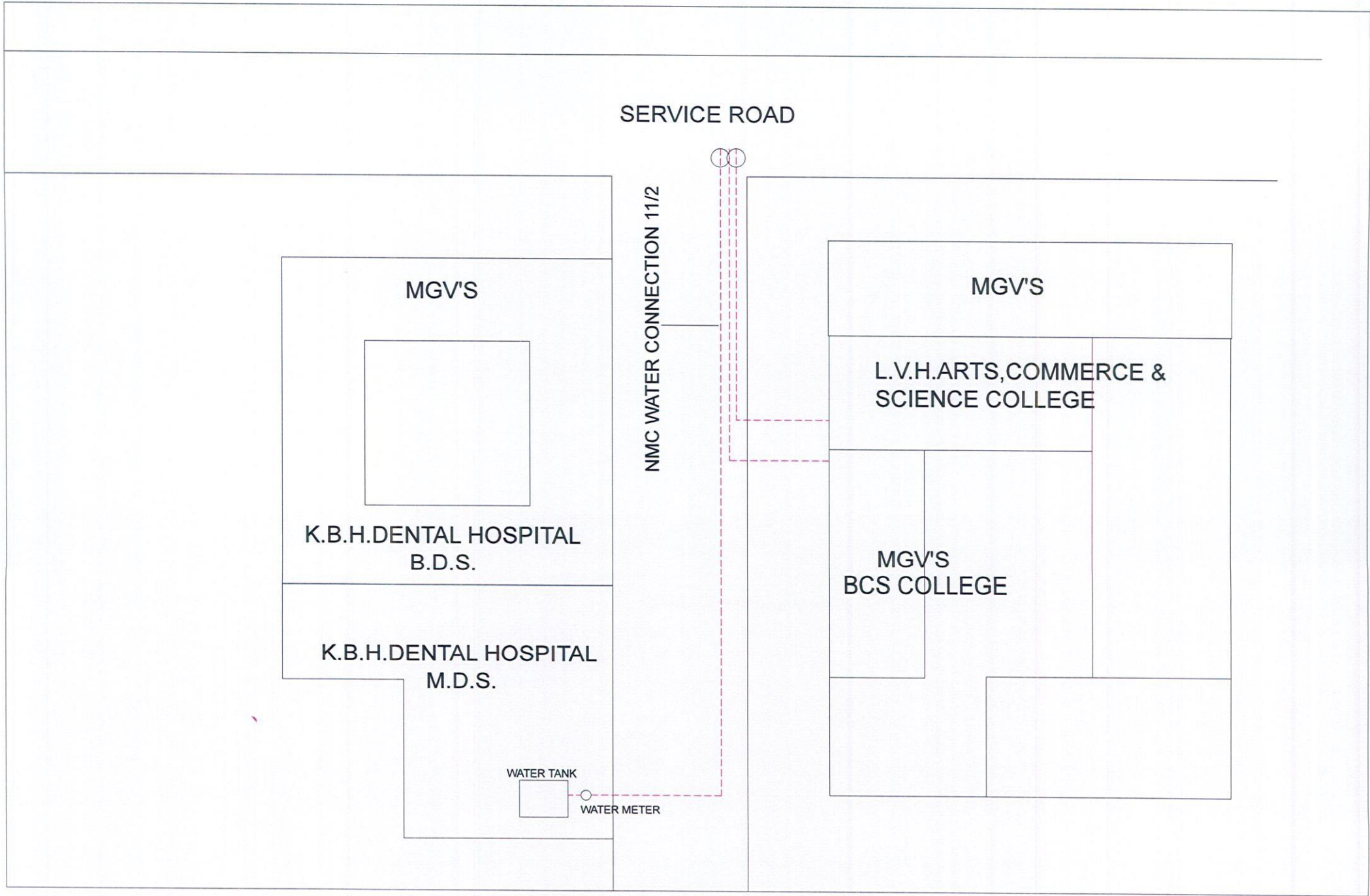
Water Distribution System Layout


