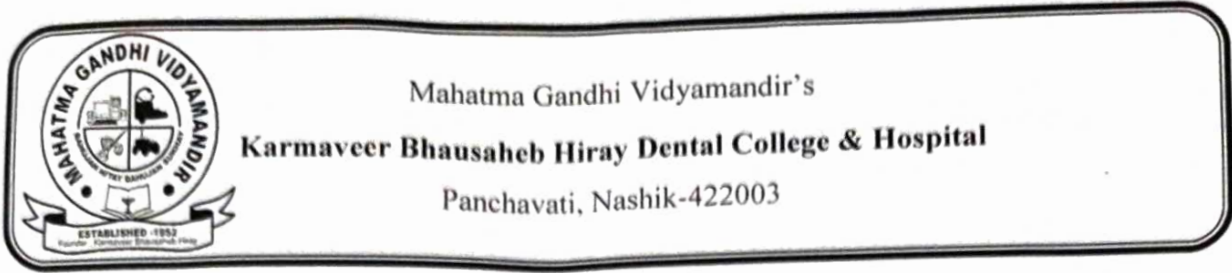


The parties here to agree as follows:

1. Party one agrees to provide place and shall allow teaching and training of undergraduate students in the premises of Nutan Trimbak Vidyamandir, Trimbakeshwar as it lies in the rural areas of Nashik.
2. As per the agreement, the undergraduate students and interns shall work under the supervision of faculty of MGV's KBH Dental College , Nashik in the satellite centre set at Nutan Trimbak Vidyamandir, Trimbakeshwar.
3. Party two agrees to conduct dental check-up and treatment of the needy, native, rural, tribal population from the nearby areas and school children in these premises as allowed by party one.
4. Party two shall arrange six days OPD Clinic in a week at Nutan Trimbak Vidyamandir, Trimbakeshwar under the supervision of faculty of MGV's KBH Dental College and Hospital, Nashik.
5. Dental check up and treatments like scaling, restorations and mobile tooth extractions by party two at Nutan Trimbak Vidyamandir, Trimbakeshwar will be free of cost. For other treatments needed patients will be referred to the MGV's KBH Dental College and Hospital, Nashik.
6. The MGV's KBH Dental College and Hospital, Nashik (party two) will provide and maintain a dental chair and fully functional dental unit to fulfil the requirements for the dental check up and above said treatments.
7. Party one agrees that it will not venture into similar agreement with other dental institution.

8. In case if needed, party one will permit for residential facility for the faculty , students and interns of MGV's KBH Dental College and Hospital, Nashik who are providing their services at the satellite centre in Nutan Trimbak Vidyamandir, Trimbakeshwar.
9. The MoU will be valid for a period of 5 years (from the period of execution of the MoU) to ensure smooth conduct of the activities under the MoU. The parties may further extend or renew the MoU on terms and conditions as mutually agreed. Within the aforesaid period of 5 years, the MoU may be terminated by the parties .Once the MoU is terminated, no new activities shall be carried out under this MoU. However treatments which are scheduled before the date of the termination notice, shall be completed as per the MoU.

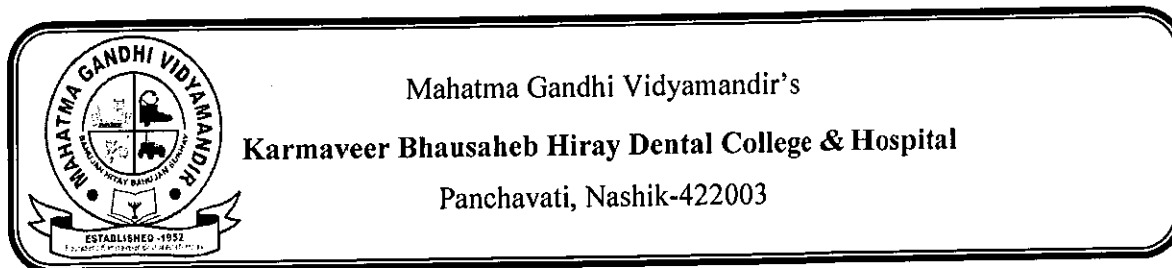
